11.073 PUBLIC QUESTION TIME

11.074 PRESENTATION BY TIM SLANEY, HEAD OF RBWM PLANNING AND DEVELOPMENT

Tim Slaney did a presentation on upcoming government legislation followed by questions and answers.

The Chairman informed us that RBWM had recently resurfaced the car park at the Almshouses and had done a very good job. The Chairman was to write to RBWM to thank them. The Chairman has also rejoined the Executive Committee of BALC. Concern was expressed that the loans applications for the hub and the Church Wall have not been completed. We have to ensure as much information as possible is sent with new loan applications now as the application process has changed.

The Clerk reported that an Asbestos Survey will be carried out on the Hub building. Works are due to start at Crimp Hill Cemetery to prepare for further burial plots.

11.080 BOROUGH COUNCILLORS REPORTS

Cllr. M. V. Beer reported a new bus shelter in the area of Ricardo Road. We were informed that there are currently only two enforcement officers working for RBWM as concerns were raised that enforcement action had not happened at Newtonside Orchard. Cllrs. Mrs L. C. Jones and Mrs J. K. Dawson attended a presentation on Aircraft Noise. Old Windsor is to be disadvantaged by ending of the Cranford Agreement resulting in many more flights and much more noise. Cllr. Mrs J. M. Mynott attended a meeting at the Day Centre. They are struggling for funding and have concerns they are not getting the same level of financial support as other day centres. CRB forms are taking too long to be processed. The Borough Councillors will follow this up.
