Members had an OBJECTION to this application as there is a severe lack of parking in this road and adding an additional bedroom without adding additional parking will only make the situation worse.

Members also discussed application 22/00400. After realising that some information was included that was not apparent when they originally considered it, members agreed that they wished to change their comment from **NO OBJECTION** to: Members had a **STRONG OBJECTION** to this application. This property suffered some flooding in the 2014 floods. The Burfield Ditch is mainly on the property of 158A and we can see no agreement with that owner regarding working on this. There is no EA report on the proposed plans and they objected originally which our members agree with. If it is approved then an archaeological survey should be done on previously unbroken ground due to its proximity to the river in accordance with the Old Windsor Neighbourhood Plan Policy OW10. Members are also concerned that this application will not be in accordance of the Old Windsor Neighbourhood Plan OW14 Protection of Natural Habitats, Landscape and Ecology.
